Executive Summary

Though the previous Annual General Meeting (AGM) of The Australian Sikh Association Limited (ASA) was held on 19 March 2023 and reconvened on 2nd April 2023, Board has decided to conduct ASA elections on 19 Nov. 2023 followed by an AGM on 26th Nov. 2023. Last time ASA elections were delayed and now Board has taken a bold decision to conduct elections and AGM well in time that budget & finances can be streamlined according to the financial year.

Despite many challenges, Board has conducted 35 meetings since 6 March 2022 and 19 meetings during the FY 2022-23, to plan and execute different tasks. Throughout, our focus has been in mitigating any potential risks and ensuring the safety/hygiene and well-being of the Sangat coming to attend Gurdwara Sahib. We have improved the overall safety and functional efficiency at the ASA premises. Increased number of the Sangat attending Gurdwara Sahib resulted in \$2,263,012 as the Golak offerings in the FY 2023, whereas it was \$1,721,016 during in FY 2022.

We successfully applied and received \$343319.96 in Govt. grants which helped us in improving the infrastructure like renovation of ASA properties, technology upgrades, land scapings and drainages, upgrading of amenities, athletics tournaments, facilities for the seniors and covering allowances of teachers and trainers etc. We have updated the daily "Hukamnaama" and other information display units. Pergola of GNPS has been fitted with curtains, ceiling fans and audio & video system for the seminars etc. In addition, \$2.5 millions for the Master Plan Phase 1 (parking, multipurpose hall, and school classrooms) and \$280,000 for bathrooms upgrade have been committed by the NSW Govt. We have progressed well on the kitchen extension project and expecting to open on the "Guru Nanak Dev Ji's Gurpurab" on 27th Nov. 2023. We are hoping to launch the revamped website including online booking system, on the "Bandi Chor Diwas" on 12th Nov. 2023.

We have made significant financial savings, including \$5,000 of interest payment saved per month by paying of the mortgage on 21 Meurants Ln Glenwood property, we are paying 40% less for the accounting and audit services, savings on the cleaning services by employing students on casual basis etc. ASA's charitable grocery shop (Sacha Sauda) opened for the convenience of the Community has resulted in \$75,344 donations from grocery sales in the FY 2023, in comparison to the sales of \$34,049 during FY in 2022. We are providing free Kakaars (Kanghas & Karas) at Sacha Sauda, and Kashehras and Kirpans (Small Sri Sahib) are available at very nominal charges. We have achieved milestones in the education, for example more than 900 students were enrolled at the Guru Nanak Punjabi School (GNPS) in 2023 and record per capita grant of \$136,884.98 received in the current year. An annual function of GNPS was held where teachers, students and volunteers were honoured. Teachers of GNPS and SRE classes attended refresher training courses and new resources for Punjabi teaching have been provided.

Our team has successfully conducted athletics tournaments which were of great interest to the Sangat and thousands of members attended the sports carnivals. We have organised regular Gatka classes for the youngsters on every Sunday. Gatka training classes of children and adults are conducted by the experienced trainers, and there are regular exercise training classes for the seniors.

We were able to provide relief to the flood victims using ASA Ltd. Charitable Trust Funds. \$60,000 has been donated for Punjab floods relief and \$20,000 donated for Pakistan floods relief. Our flood relief was held in high regard which significantly enhanced our community's public profile. Our seniors participated in the ANZAC Parade, and Blacktown City Festival Street Parade.

The Board of Directors is very much humbled and privileged to acknowledge and thank the community for their contributions and help. Our special thanks go to our Kaafla Members and Seniors for their support and guidance. At last, but not least, we are highly thankful to Late Er. Dalbir Singh Gill for donating his estate to ASA, as a cheque of \$550,000 has been received and more donation is coming in the form of shares etc., as per his will. We are also thankful to Late Dr. Gurcharan Singh Sidhu as a cheque of \$20,000 has been received as per his will. ASA will remain indebted to both Gill and Sidhu family for their enormous donations for the Sikh Community.
