Note: The quorum of minimum two hundred (200) members must be present in person. A member attending both as a member and proxy shall only be counted once in determining the quorum.

Proxy: Clause 9.7.7A of the ASA constitution stipulates "Subject to Clause 9.7.7B, a Member may appoint a person as the Member's proxy to attend and vote for the Member at the meeting, if such Member:

- a) resides outside Greater Sydney on the date of the relevant meeting, or
- b) resides in Greater Sydney, and on the date of the relevant meeting, he or she will be:
 - i) absent from Greater Sydney; or
 - ii) hospitalised on the date of the relevant meeting."

Proxy form duly signed by Company Secretary and Returning Officer is being sent to members residing outside Greater Sydney. Any member residing in Greater Sydney who would like to appoint a proxy as per clause 9.7.7A (b) may obtain a proxy form at the ASA office or download using a link provided (*ASA proxy Form 2023.pdf*). Proxy submitted on any other form will be invalid. The details/documents required for the proxy are listed on the proxy form. Proxies given in duplicate will the rejected. Please note:

Clause 9.7.8 "A Member shall not be entitled to hold more than two (2) proxy votes."

Clause 9.7.9 "A proxy does not have the authority to speak or vote for a Member at a meeting while the Member who appointed the proxy is at the meeting."

The proxy form and all other documents required under this clause 9.7.7B should be received by the Company Secretary at least forty-eight (48) hours before the AGM Day, (by no later than 1:30 PM on 24 November 2023). Proxy forms submitted for the ASA election by 16 November 2023 and correctly completed shall also be valid for the AGM.

Photo ID: Please note that a photo ID (Australian Driver's License/Passport or other photo ID issued by Australian authorities) is required for identification purposes.

Voting right of ASA members as per:

Clause 8.7.4 "A member shall be entitled to attend and at any general meeting of the Company only if he/she has been a duly registered Member for at least ten (10) calendar months prior to the date when the meeting is held."
